### Why Am I Required to Provide This Form Every Academic Year? (For U.S. Citizenship Status)

All FAFSA applications are matched with Social Security Administration (SSA) records to verify U.S. citizenship status, name, date of birth, and Social Security number (SSN).

If you have not provided sufficient proof of U.S. citizenship to SSA to update the U.S. citizenship status on your SSA records, the Department of Education will require the school to collect proof of U.S. citizenship from you to verify your U.S. citizenship status. *\*If your SSA records have not been updated, you may potentially be asked to verify citizenship status each year.* 

Although this update is not required to receive financial aid, we recommend you contacting the SSA to have your record corrected so that you can potentially avoid providing this form and documentation in future academic years.
